#### New "Building to COP26" Partnership Announced Ahead of the UN Climate Change Conference

A coalition led by C40, the World Green Building Council, and other organizations recently announced a new initiative, #BuildingToCOP26. This partnership will promote collaboration for climate change action ahead of the Cities, Regions, and Built Environment Day at the 2021 United Nations Climate Change Conference (COP 26), which will be held from November 1-12 in Glasgow, Scotland. The coalition is a group of business and government organizations focused on sustainability in the built environment. Currently, buildings are responsible for almost 40% of global energy-related carbon emissions and 50% of all extracted materials. Of the 186 countries that have submitted Nationally Determined Contributions to the United Nations Framework Convention on Climate Change, 136 countries mention buildings, 53 countries mention building energy efficiency, and 38 specifically reference building energy codes. The Coalition calls for emissions from building projects globally to be halved by 2030, and net-

zero life-cycle emissions for all buildings by no later than 2050, including operational and embodied carbon. More information can be found on the Building to COP26 page <a href="here">here</a>.

#### Detroit, Michigan School District Consults with ASHRAE Michigan Chapters on COVID-19 Mitigation

The Royal Oaks School District in the Detroit, Michigan metro area recently installed germicidal ultraviolet light (UV-C) purification units in an effort to mitigate COVID-19. School district officials consulted with the Detroit and Western Michigan Chapters and referred to ASHRAE guidance as a major factor in their decision regarding a range of school building improvements made possible by \$1.5 million in funding from the Elementary and Secondary School Emergency Relief Fund.
